**8.14.13** - Public hearing on the proposed tax rate and Board passed the rate as advertised at EBOE Meeting - there was also a presentation on the specifics of the facilities tax and an overview of our long range plans / needs

**8.20.13** - Board Presentation on the validity of our ads and to show where the specific amounts in our ads are verified by the Sheriff and our Annual Financial Report at EBOE Meeting

**8.21.13** - Ad 3 published in Henry County Local to show that tax rate had been established and how the community could begin the recall process

**9.26.13** - Tax update and budget creation /overview given the proposed new tax rate at EBOE Meeting

**10.1.13** - Henry County mails tax bills (Yellow Mailer) without any Eminence Schools taxes included because 45 day recall period had not ended prior to September 15th

**10.22.13** - Tax update and discussion with answering questions regarding the process at EBOE Meeting

**11.15.13** - Tax bills (Blue Mailer) are mailed with only Eminence Schools taxes on them in their entirety - increase from prior year of \$72 per \$100,000 of assessed property value

## **To determine if your tax bill is correct:**

*(using your blue card received on or around November 15th)*

1. Take your assessed property value and divide by (\$100).
2. Then multiply the number you get by (.738).

## **To determine the increase in your school tax:**

*(using your blue card received on or around November 15th)*

1. Take your assessed property value and divide by (\$100).
2. Then multiply the number you get by (.072).
